PROTOCOL

of the Vth Session of the Joint Greek - Bulgarian Commission for the development of Tourism.

The Joint Greek - Bulgarian Commission for the development of Tourism, called hereafter «Commission» held its Vth Session in Athens from December 7 to 11, 1976.

The Session was opened and presided over by the Head of the Greek Delegation Professor George Daskalakis.

The Commission unanimously adopted the following Agenda:

1. Exchange of information on the development of tourism in both countries during the year 1976 and views for the year 1977.

2. Review of the bilateral tourist relations.

3. Measures for further development of the mutual tourist traffic between both countries and from third countries as well.

4. Various other items.

ITEM 1.

Detailed information concerning the development of tourism in both countries during 1976 was presented by the Heads of the two Delegations.

The number of tourists visiting Greece and Bulgaria shows further increase and a satisfactory increase in foreign currency receipts is noted.

Both sides reported favourable forecasts for the development of tourism in 1977.

ITEM 2.

The meetings between the President of the State Council of the People's Republic of Bulgaria Mr. TODOR ZHIVKOV and the Prime Minister of the Hellenic Republic Mr. CONSTANTINOS CARAMANLIS, as well as the Final Act of the Conference on Security and Cooperation in Europe, held in Helsinki, and the Communiqué of the Athens Meeting concerning the economic and technical cooperation between the Balkan Countries, had a constructive effect on the tourism relations between the two countries.

As a result, further improvement in the cooperation in the field of tourism between the Hellenic Republic and the People's Republic of Bulgaria was noted with satisfaction.

The active cooperation between the National Tourist Organisations and the Travel Agencies of both countries effectively resulted in further increase of the tourist traffic between Greece and Bulgaria.

The activities and initiatives of the Automobile and Touring Clubs of the two countries contributed largely to the benefit of tourism.

The continuing cooperation in tourism promotion in the frame of the Balkan Conference of the Official Tourist Organisations concerning third markets, was noted again with satisfaction.

The two Delegations also appreciated the efforts made by the appropriate authorities in facilitating the travel formalities.

ITEM 3.

With a view to further strengthening the bilateral tourist relations, both sides agreed and recommended the following:

- To propose to the respective authorities of the two countries to continue their efforts for the creation of further favourable conditions for tourist travel between Greece and Bulgaria.

- A further mutual and active cooperation between the Travel Agencies of both countries should continue in order to provide:

a) better travel facilities and services, increase the number of tourists in both directions, etc...

b) increasing their efforts to attract tourists from third countries to visit Greece and Bulgaria taking advantage of existing incentives.

In the field of promotion it was suggested that:

a) further exchange of visits of journalists would be continued in order to provide information about the tourist possibilities of the two countries.

b) both sides will exchange the cultural programmes in 1977, so that Travel Agencies should be duly informed for the purpose of organising excursions.

- A close cooperation, where appropriate, in the framework of the Balkan Conference of the Official Tourist Organisations and the International Organisations dealing with Tourism.

- Exchange of statistical and other informative material.

The next Session of the Joint Commission on Tourism will be held in Bulgaria in the last quarter of 1977.

The Bulgarian Delegation expressed their thanks to the President of the National Tourist Organisation of Greece and the Members of the Greek Delegation for the warm hospitality rendered and the spirit of cooperation and understanding prevailing during the Session.

PROTOCOL

of the VIth Session of the Joint Greek - Bulgarian Commission on Tourism.

The VIth Session of the Joint Greek - Bulgarian Commission on Tourism took place in Sofia from December 11 - 12, 1978.

Delegates to the Session of the Commission were:

The Commission adopted the following Agenda:

1. Exchange of information on the development of Tourism in the People's Republic of Bulgaria and the Republic of Greece for the period of 1977/78 and prospects for its future development.

2. Review of the bilateral tourist relations in conformity with the Protocol of the last Session of the Joint Commission.

3. Measures for further development of the mutual tourist traffic between the two countries as well as that of tourists from third countries.

4. Miscellaneous.

The Session was opened and presided over by the Head of the Bulgarian Delegation, Mr. Georgi Evtimov.

In their opening speeches the Heads of the Delegations expressed their mutual satisfaction with the successful

improvement of the bilateral relations in the field of tourism as a result of the new important evolution in the development of international relations in Europe and in the world, determined above all by the Final Act of the Conference in Helsinki on Security and Cooperation in Europe and the Joint Communiqué of the Athens Meeting of Experts, concerning the economic and technical cooperation and also the exchange of visits between the Prime Minister of the Republic of Greece, Mr. Constantinos Caramanlis and the President of the State Council of the People's Republic of Bulgaria, Mr. Todor Zhivkov.

ITEM 1:

Detailed information concerning the development of tourism in both countries in the course of 1977 and the approximate data for 1978 was submitted by the Heads of the two Delegations.

The Greek Delegations presented a detailed report, related to the solution of some problems concerning camping sites, air traffic protection of environment and monuments of cultural value.

The Bulgarian Delegation informed about the measures to be undertaken with a view of protecting the cultural and historical monuments in connection with the increasing number of tourists, modernization and reconstruction of the existing infrastructure, in converting the old traditional villages for tourist purposes, improvement of staff selection, vocational training and qualification, higher level of services and catering for individual tourists, etc.

The two Delegations underlined the great importance of the traditional cities, villages and settlements and converting them into attractive tourist sites, having preserved their cultural and traditional values and the problems, concerning these reconstructions.

ITEM 2:

The two Delegations analyzed the present state and prospects of the tourist relations in the spirit of the signed Protocol of the Vth Session of the Joint Commission, which was held in Athens in December, 1976.

It was noted that the recommendations issued by the previous Commission are being in general successfully implemented as a result of the joint efforts of the Official Tourist Organizations and the Travel Agencies of both countries.

Up to now the number of the Greek and Bulgarian tourists has increased, the forms and programmes have been diversified; the stay of the original tourists has been extended; the quality of the tourist services has been improved, etc.

A good start regarding having tourists from third countries to Greece and Bulgaria has been registered, although there exist unlimited possibilities in this respect.

The coordination regarding the activities of the two countries in number of international organizations, especially in the WTO, was stated with satisfaction.

ITEM 3:

After a detailed survey of the present state and future of the tourist relations between the two countries and with a view to their further improvement, the two Delegations agreed to recommend the following:

a) The Travel Agencies of the two countries to continue their efforts for increasing the tourist traffic between Greece and Bulgaria to create more favourable conditions for travel through:

— diversifying the existing programmes and offering of new ones.

— measures for extension of the length of stay of the tourists from both countries.

— suggesting new forms of travel such as: weekend trips; professionally orientated tours; youth trips; specialized tours (on the occasion of cultural, sport and other events); stay in the resorts of the two countries, etc.

b) the Travel Agencies of both countries to study all possibilities aiming at the extension of tourist traffic from third countries on combined tours and short-term visits. In this respect they should coordinate their activities regularly.

c) in the field of tourist advertising and information:

- broadening the exchange of tourist information materials, tourist films, etc. for the purpose of promoting the tourism in the two countries.

- to exchange visits of journalists, travel writers, film and TV teams.

- to study the possibilities for organizing tourist exhibitions in Greece and Bulgaria.

- coordination of certain activities on behalf of the National Tourist Offices abroad for promotion of tourism in the two countries, especially on some new markets.

d) to recommend to the National Civil Aviation Authorities of the two countries to study the possibilities of opening of regular seasonal connection between Varna and Athens as well as carrying out charter flights between certain resort areas of the two countries according to the respective national legislation.

e) the Official Tourist Organizations of the two countries will continue their efforts for closer cooperation where appropriate in the activities of the international organizations dealing with tourism, especially the World Tourism Organization, etc.

f) to organize visits of experts with a view of exchanging their mutual experience and studying out of some some general problems in the field of tourism.

The next Session of the Joint Commission on Tourism will be held in Greece in the last quarter of 1979.

The Greek Delegation expressed their thanks to the President of the State Committee of Tourism, Mr. Georgi Evtimov and the members of the Bulgarian Delegation for the warm hospitality rendered and the spirit of cooperation and understanding, prevailing during the Session.

The Joint Greek-Bulgarian Commission for the Development of Tourism held its VII Session in Athens between October 10th and 16th, 1979.

The Session was opened and presided over by the Head of the Greek Delegation, Professor George Daskalakis. The Opening Session was attended by the Secretary General of the NTOG, Mr. Panayotis Lambrias.

The Commission unanimously adopted the following Agenda:

1. Exchange of information on the development of Tourism in both countries during 1979 and views for the year 1980.

2. Review of the bilateral tourist relations.

3. Measures for further development of the mutual tourist traffic between both countries and from third countries as well.

4. Other items.

In their opening speeches, the Heads of the delegations expressed their satisfaction at the successful development of tourist relations between the two countries.

They also stressed the special contribution of tourism to the overall relations between Greece and Bulgaria, which are fully within the spirit of good neighbourliness and understanding determined by the foreign policy of the two countries, in the Final Act of the Helsinki Conference on Security and Cooperation in Europe, and the Joint Communiqué of the Athens Meeting concerning economic and technical cooperation.

ITEM 1

Detailed information was presented as regards the development of tourism in both countries in the course of 1978 and the first semester of 1979 and the prospects for the second semester of 1979 and the coming year.

Both delegations noted the special attention given by the NTOs to the development of tourism, also measures and legislation undertaken in that field.

The Bulgarian side reported details for the implementation of some new projects connected with different types of tourism such as winter tourism, balneological tourism, transit traffic, etc.

The Greek side presented detailed statistical data and gave information on certain measures taken to develop new forms of tourism in Greece such as the preservation of traditional settlements, the «bed and breakfast programme», winter tourism. It was stressed that special attention was given to sea tourism – cruises, yachting, etc.

ITEM 2.

Both delegations noted with satisfaction the successful fulfilment of the recommendations of the Protocol of the VI Session of the Joint Commission held in Sofia in December 1978.

As a result of the efforts made by the NTOs and the Travel Agencies of both countries, a substantial increase was reported in the tourist traffic between Greece and Bulgaria.

Both sides noted that the existing good possibilities for attracting tourists from third countries – either on short - stay excursions or on combined tours – are not yet fully exploited and more active cooperation is recommended.

They also stated with satisfaction the useful cooperation achieved during the III General Assembly of the WTO at Torremolinos in September 1979.

ITEM 3.

With the aim of further developing the tourist relations between Greece and Bulgaria, both sides agree to recommend as follows:

a) - The Travel Agencies to continue their cooperation for a further increase of tourist traffic between the two countries taking advantage of the existing favourable conditions.

- Special endeavours to be made to promote travel of tourists from third countries, especially from prospective markets.

- A meeting to be held between the Hellenic Association of Travel Agencies and Balkantourist and other Bulgarian Travel Agencies in order to examine some technical details and suggest proper solutions concerning their field of activities. Place and date for that meeting will be fixed at a later date by the interested parties.

b) - For the purpose of acquaintance with the tourist facilities of the two countries, exchange of tourist promotional material to be undertaken, as well as exchange of visits of journalists and writers on tourism.

c) - The Bulgarian side expressed the wish that Tourism be included in an anticipated Greek trade exhibition scheduled to be held in Sofia at the end of this year.

d) - To underline and recommend to their Travel Agencies the importance of including some significant cultural and musical events in their tourist programmes. Relevant information concerning such events organized or sponsored by the NTOs will be exchanged.

e) - To exchange visits of experts and know - how in different fields of tourism such as: hotel management, training of personnel, research on matters relating to tourism, organization of marinas, balneological and winter tourism.

f) - In view of the anticipated establishment of a new border crossing between Greece and Bulgaria, to suggest to the responsible authorities that they study the possibilities of creating appropriate border facilities.

The next Session of the Joint Commission on Tourism will be held in Bulgaria in 1980.

The Bulgarian delegation expressed their thanks to the President of the NTOG, Professor George Daska-

Αἱ δύο Ἀντιπροσωπεῖαι ἐξήτασαν τὴν παροῦσαν κατάστασιν καὶ τὰς προοπτικὰς τῶν τουριστικῶν σχέσεων ἐντὸς τοῦ πνεύματος τοῦ ὑπογραφέντος Πρωτοκόλλου τῆς Vης Συνόδου τῆς Μικτῆς Ἐπιτροπῆς ἡ ὁποία ἐπραγματοποιήθη εἰς Ἀθήνας τὸν Δεκέμβριον 1976.

Ἐσημειώθη ὅτι αἱ συστάσεις τῆς προηγουμένης Ἐπιτροπῆς γενικῶς ὑλοποιοῦνται ἐπιτυχῶς ὡς ἀποτέλεσμα τῶν κοινῶν προσπαθειῶν τῶν Ἐπισήμων Ὁργανισμῶν Τουρισμοῦ καὶ τῶν Ταξιδιωτικῶν Γραφείων ἀμφοτέρων τῶν χωρῶν.

α) Τὰ Ταξιδιωτικά Γραφεία τῶν δύο χωρῶν νὰ συνεχίσουν τὰς προσπάθειάς των πρὸς αὐξησιν τῆς τουριστικῆς κινήσεως μεταξύ Βουλγαρίας καὶ Ἑλλάδος διὰ τὴν δημιουργήσιν περισσότερων εὐνοϊκῶν ὁρῶν ταξιδίων διὰ :

—τῆς διαφοροποιήσεως τῶν ὑπαρχόντων προγραμμάτων καὶ τῆς προσφορᾶς νέων,

Ἡ Ἑλληνικὴ πλευρὰ ἀνέφερε λεπτομερῆ στατιστικὰ στοιχεῖα καὶ παρέσχε πληροφορίας ἐπὶ ὀρισμένων μέτρων ληφθέντων πρὸς ἀνάπτυξιν νέων μορφῶν τουρισμοῦ εἰς τὴν Ἑλλάδα ὡς ἡ προστασία παραδοσιακῶν οἰκισμῶν, τὸ πρόγραμμα «διανυκτερεύσεις καὶ πρωινό», χειμερινὸς τουρισμός. Ἐτονίσθη ὅτι ἐδόθη εἰδικὴ προσοχὴ εἰς τὸν θαλάσσιον τουρισμόν—κρουαζιέρες, YACHTING κ.λπ.

Ἀμφότεραι αἱ Ἀντιπροσωπεῖαι ἐσημείωσαν μετὰ ἱκανοποίησιν τὴν ἐπιτυχὴ ἐκπλήρωσιν τῶν συστάσεων τοῦ Πρωτοκόλλου τῆς Vΐης Συνόδου τῆς Μικτῆς Ἐπιτροπῆς ἡ ὁποία ἔλαβε χώραν εἰς Σόφίαν τὸν Δεκέμβριον 1978.

Ὡς ἀποτέλεσμα τῶν προσπαθειῶν τὰς ὁποίας κατέβαλον οἱ Ἑθνικοὶ Ὁργανισμοὶ Τουρισμοῦ καὶ τὰ Ταξιδιωτικὰ Γραφεῖα τῶν δύο χωρῶν ἀνεφέρθη ἡ οὐσιαστικὴ αὐξήσις τῆς τουριστικῆς κινήσεως μεταξὺ Ἑλλάδος καὶ Βουλγαρίας.

Μετὰ σκοπὸν τὴν περαιτέρω ἀνάπτυξιν τῶν τουριστικῶν σχέσεων μεταξὺ Ἑλλάδος καὶ Βουλγαρίας ἀμφότεραι αἱ πλευραὶ συνεισέφεραν νὰ προβοῦν εἰς τὰς ἀκολουθούσας συστάσεις :

α) Τὰ Ταξιδιωτικὰ Γραφεῖα νὰ ἐξακολουθήσουν τὴν συνεργασίαν τῶν διὰ μίαν περαιτέρω αὐξήσιν τῆς τουριστικῆς κινήσεως μεταξὺ τῶν δύο χωρῶν ἐπωφελοῦμενα ἀπὸ τοὺς ὑπάρχοντας εὐνοϊκοὺς ὅρους.
